To assure that the highest quality products are sold to consumers, I understand and agree that:

- ❖ I reside and/or own property in Tuolumne County.
- ❖ All agricultural products marketed under the Farms of Tuolumne County logo are grown in Tuolumne County.
- ❖ All processed agricultural products marketed under the Farms of Tuolumne County logo contain a minimum of **60%** ingredients that are grown in Tuolumne County.
- ❖ Farms of Tuolumne County promotional materials including the logo are restricted in use to general and corporate members in good standing. One caveat regarding promotional material: the metal sign presented to new members is theirs to keep even if that member should decide not to renew membership.
- ❖ Permission to use the Farms of Tuolumne County promotional materials including the logo can be withdrawn by a vote of the Farms of Tuolumne County Board of Directors for failure to adhere to the membership agreement.
- ❖ The Farms of Tuolumne County membership year is January 1 through December 31 in each calendar year. Membership benefits including the use of the promotional materials and logo. Membership is for one (1) membership year only and must be renewed annually to receive continued benefits.
